**CONDITIONS OF ENTRY**

1. Riders must be TC&TP Inc and ACA Members or Day Members.
2. All Riders must compete with split reins, correct riding boots and Helmets (Aust. 3838)
3. Competitors must abide by all ACA and TC&TP Inc Club Rules, Safety Requirements and Codes of Conduct
4. Queries regarding runs should be addressed to a Riders Rep as soon as possible after your run.
5. Any competitor who wishes to lodge a complaint at an affiliated campdraft must lodge the complaint in writing with the Secretary of the host committee within one (1) hour of the incident taking place. A fee of \$20 must be lodged with the complaint. If the complaint is dismissed by the Committee, the \$20 is forfeited.
6. Scratchings/variations of entry available (no fee) if Entry Sec. notified by 9pm Tuesday prior
7. After this time entries are non-refundable except when accompanied by a Doctor or Vet Certificate.
8. **DOGS** are not encouraged at Campdrafts and should be **kept on a Leash or Tied Up AT ALL TIMES.**
9. No Late Entries Accepted. **Entries Close** 9 pm Sunday 6<sup>th</sup> December or Last Post Friday 4<sup>th</sup> Dec.
